#### Communications and engagement:

The CP had a great discussion about how to move the comms and engagement forward for the River Don.

The start of this will be the comms and press release around the Follingsby Max river restoration today that the EA and Highgrove Group will be putting out next week and #tagging partners in. ACTION Sue Ambrosi to work with Highgrove Group on joint press release.

The EA have invited their comms and engagement team to help with this work.

The idea was put forward that we should start with a couple of case studies championing the great work happening in the catchment – ACTION Rob Carr to put this together by end of year.

The CP also discussed the vision and the reviving the River Don Revival 2 pager – it was agreed that these will be circulated for partners to comment on by the end of the year – ACTION All by end of year.

All partners were asked to put forward options for any new comms to be used/publicised. -ACTION All by end of year.

Gayle Wilson from GBC had previously circulated some comms channels - ACTION Gayle Wilson to recirculate.

The partners also discussed a possible #tag for the partnership

It was noted that there is a river Don in Yorkshire so the #Tag that we will use to distinguish our river Don is #NEriverdon

## £8K Northumbrian Water funding

Mark Dinning put a proposal to the CP about how to use this funding – the proposal was to focus on pulling future projects together and look for the most appropriate funding using consultants: Keith Bowey (GEES), Mark Parnell (EN-Mapping).

- bringing in a GIS consultant to map existing data and flag up opportunities
- Identify 5 project ideas based on the mapping
- Develop these ideas
- Select one or more projects to put forward for funding and make funding application
- Final output to be 1 funded project with a delivery partner in place.

After some discussion Mark will refine to proposal after discussing the GIS aspect with ERIC. Mark Dinning to provide feedback in next 2 weeks - output expected to be in the next 6 months. ACTION Mark Dinning.

## **International Advanced Manufacturing Park**

#### EA update:

<u>IAMP One</u> is underway after getting permission in the summer. The EA are still waiting for the discharge of conditions applications to come in, however we are currently assessing their flood risk permits.

Scoping report submitted to us September and we have responded. The inspector has now commented on this consultation.

Submission of the DCO June 2019

River Don and IAMP Two

<u>IAMP Two</u> Scoping Report submitted in September advised that a WDF impact assessment wasn't required as there wouldn't be an impact on the River Don. Something that we don't agree with. In our response we asked for an assessment to be carried out, something the planning inspector has agreed with and IAMP are now carrying out this work through JBA.

We've held a meeting with Systra and WSP about our position on river restoration and flood risk impacts of the development, in particular the bridge and outfall structures.

We have advised that we expect to see reference to some form of river restoration within the PEIR and design of Ecological Land Mitigation Area (ELMA) should include river restoration. We hope to agree to the principles through a Statement of Common Ground prior to the submission of the DCO. However at this stage it is good to see that the inspector is agreeing with our approach and has made reference to the work at Follingsby in their Scoping Opinion letter, see below:

Drainage mitigation should have regard to mitigation measures developed for the South Follingsby development, located upstream of the Proposed Development.

The ES should provide details of any proposed mitigation measures for the River Don and the ELMA, and explain consistent with local planning policy, to maintain its current classification and to support the WFD objective of Good potential by 2027.

We hope to be working closely with IAMP and their team on the DCO and design of the ELMA to look at the impacts of WFD and flood risk and come to a position where all parties are in agreement prior to the DCO submission.

It was agreed that it would be beneficial for the IAMP Environmental Group which IAMP have previously held to be reconvened. ACTION Rob Carr to discuss with James Hudson (EA) and Paul Armin (SCC)

## Testos/A19 improvements by Highways England

£950k earmarked on a recent update from HE for Don improvement but no specific details have yet been received. Vortex separator proposed, at one location but this is a minimal contribution to catchment improvement /protection. EDF fund is currently open for applications.

ACTION Rob Carr will ask for a webinar from Highways England to explain what they plan to do on the Don with the funding

#### River Don Improvement Projects: fish obstructions / land management and bankside erosion project

Liz Walters from Tyne RT update on the Obstructions/land management project- 10 obstructions reviewed and detailed designs produced report has been produced which includes mapping of all problem locations.

Application made this year for WEIF (water environment improvement funding) funding.

This year, delivery of 4 muck bays at livery stables (essentially, constructions to provide a muck storage location which doesn't leach animal waste into the river), at present Mill Dene and Bowes meadows are underway Newton Garth and Low Meadows to be delivered by March.

Obstruction at Hedworth Dene (opposite side of road to Mill Farm Cottage) – landowner discussion is in progress.

Action Rob Carr arrange for land ownership requests to be submitted obstruction through the Dene

## NWG update - assets/misconnections/obstructions

Gateshead Council update from Peter Shield – Salt store is to remain in current location and a funding application proposed for a roofed salt barn – On drive by inspection today the salt store was predominantly uncovered. ACTION for Peter Shield to ask where the tankered off salt store drainage is disposed to

Mink have been identified on the River Don near IAMP location - Impacting on water vole populations so mink management currently ongoing.

Water vole survey catchment wide to be repeated by STC in 2019.

Greggs community funding applications to be made by Tyne Rivers Trust (5th December deadline)- Don is a key area for this proposal. Links with NWL water rangers.

PO18- 043	Gateshead - Follingsby Avenue	This misconnection is one commercial property within a small area of the industrial estate and on its own is having little to no effect on the water course. The misconnection was noticed as part of a wider pollution investigation. We are yet to gain access into the property to locate the source of the misconnection.
PO18- 026	Washington - Essex Drive	We have surveyed 59 or the 66 properties identified and found 9 to have misconnections. From those 6 properties have corrected their drainage and 3 are currently still outstanding.
PO16- 027	Gateshead - Whitehouse Crescent	We have surveyed 548 of the original 689 properties identified and found 37 to have misconnections. From those 19 have corrected their drainage and 18 are currently still outstanding. We are experiencing difficulties getting access to the outstanding surveys and we are currently considering our next steps to try and gain access.
PO16- 004	Boldon Colliery - Cheltenham Drive	We have surveyed 128 properties out of 138 and found 6 properties to have misconnections all of which have been corrected. At last inspection in June the outfall was showing signs of recovery.

PO16- 003	Boldon Colliery - Berkley / Evesham Close	We have surveyed 52 out of 59 properties and found 3 properties to have misconnections all of which have been corrected. At last inspection the outfall was not yet showing signs of recovery, we added 12 properties for survey in August 2018 but have not found any misconnections so further investigation is required to identify the source of contamination.
